In April, the NSBA & VLP initiated a new award for law students making significant contributions to the Tenant Assistance Project (TAP), an eviction defense project that launched in Lancaster County on April 1, 2020. Students receiving the "Tenant Assistance Project—Outstanding Law Student Advocate" Award must exhibit exemplary efforts in support of TAP by going above and beyond expectations in their effort to support the program and contribute to its success. Awards will be presented three times annually, in May, August and December. Students honored this past year include:

Taylor Hayes and Hannes Zetzche

During the spring semester of 2020, Taylor and Hannes developed the process and forms that would be required to facilitate a program like TAP. They attended several hearings to observe the eviction process in Lancaster County and attended numerous meetings with housing advocates across the state and nationally. They conducted a significant amount of research on the feasibility of the program and into the relevant laws and rules applicable to evictions. Taylor and Hannes were the first student attorneys to participate in the TAP program, assisting several tenants at the courthouse at the end of the spring term.

Amy Sonnenfeld and Lydia Mann

Summer 2020 was the first full semester where TAP was made part of the Clinical program at the College of Law; and, Amy and Lydia dove in head first. Each represented numerous tenants over the summer and regularly volunteered to cover additional shifts or create additional eviction defense packets to aid attorneys representing their clients. Their zeal for representing tenants was unmatched. Both Lydia and Amy continued to support TAP long after their time in the Clinic had concluded.

Tessa Lengeling and Sarah O'Neill

Tessa and Sarah began working within the TAP program in August 2020. They continued to contribute to TAP through April 2021. Sarah and Tessa collectively created more eviction defense packets and volunteered for more shifts than any other law students during the fall of 2020. Due to their additional volunteering, they were able to take on complex matters early in the semester. Both of them also continued to volunteer through TAP over the entirety of the holiday break when volunteers were sparse, and when there was a significant increase in hearings as a result of the anticipated expiration of the CDC moratorium on January 1.
